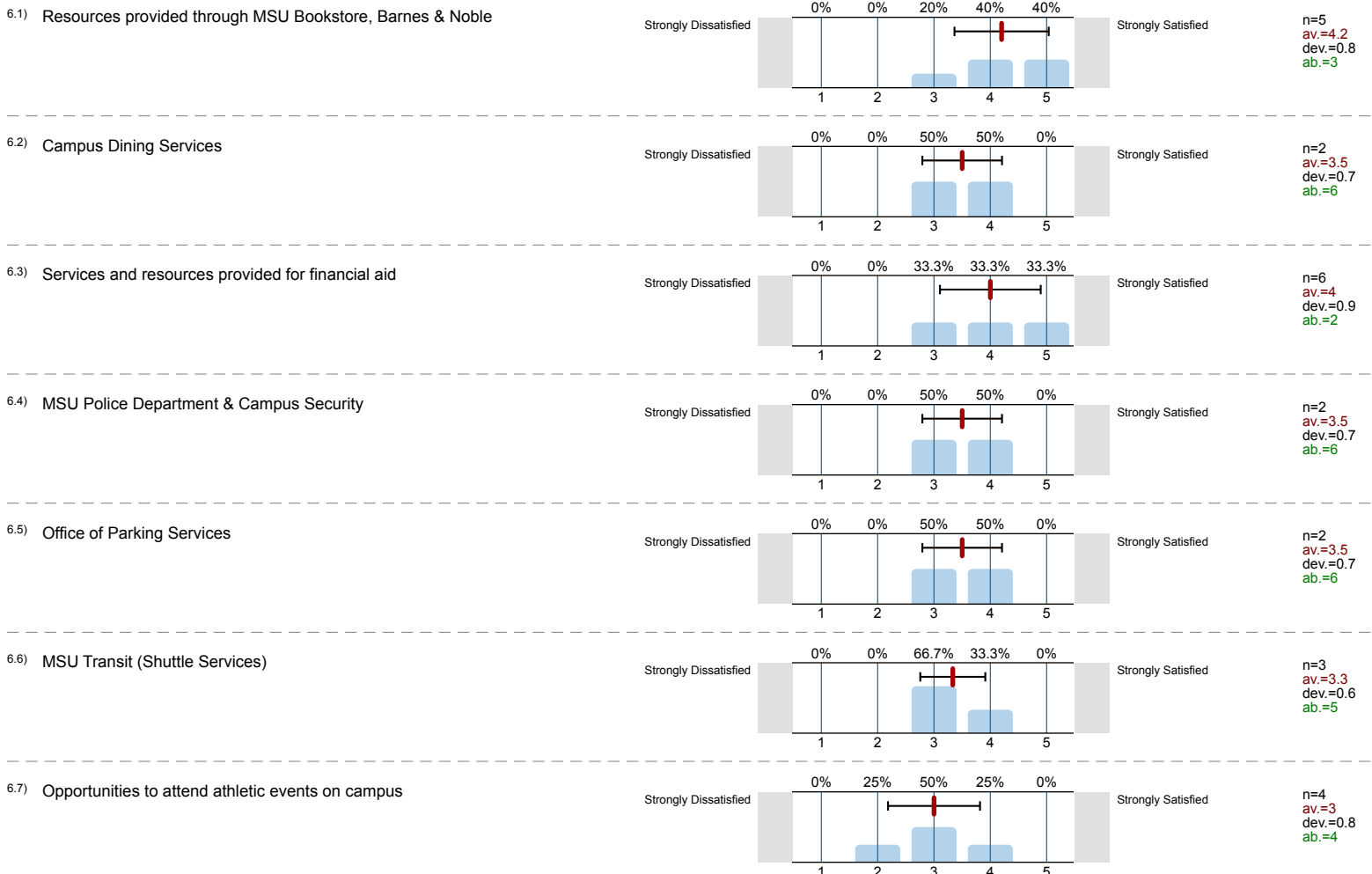

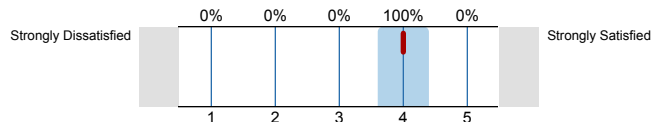

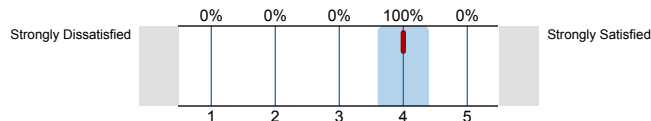

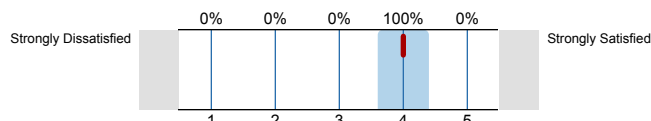

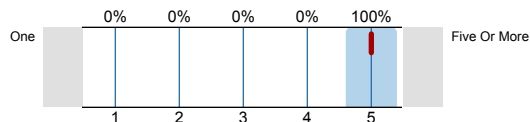

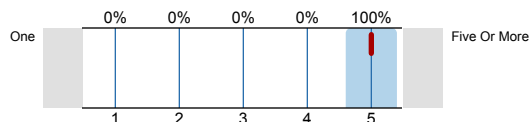

7.3) During your graduate career, how many journal articles did you submit?



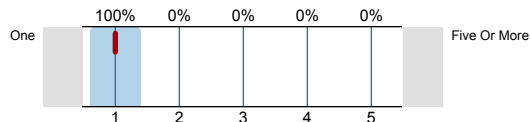

7.4) During your graduate career, how many journal articles did you have accepted?



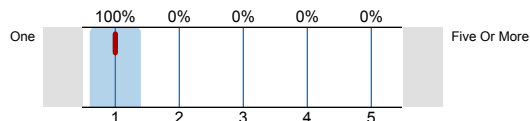
