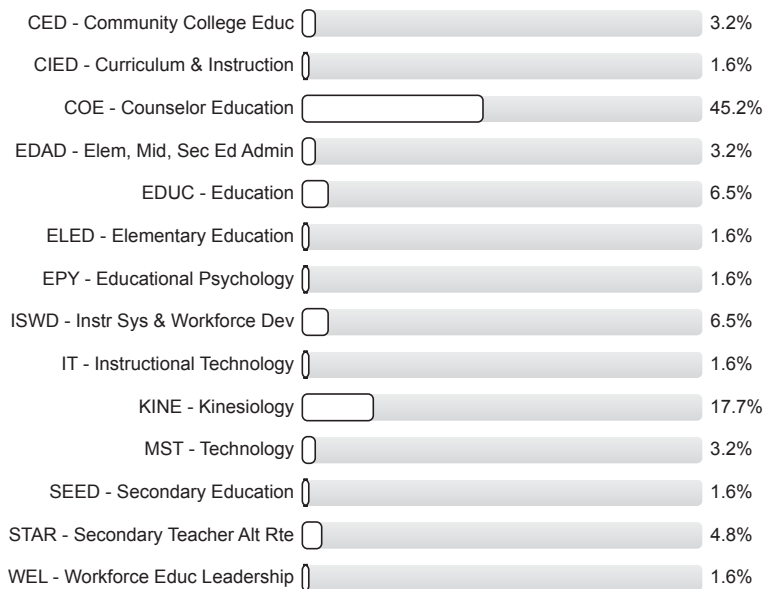

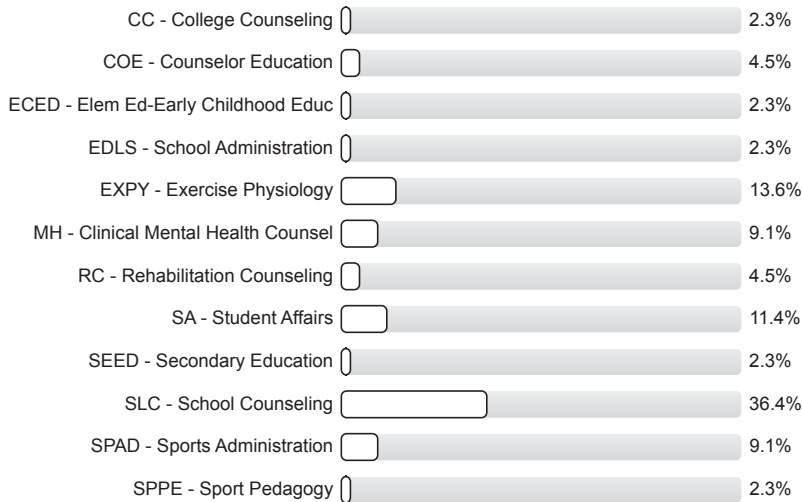

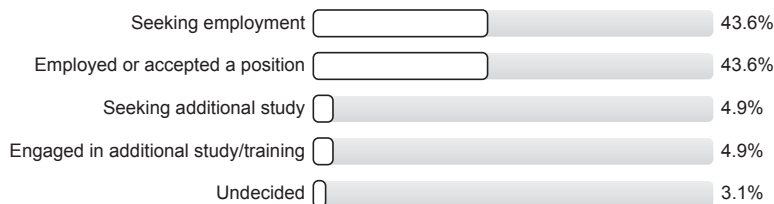

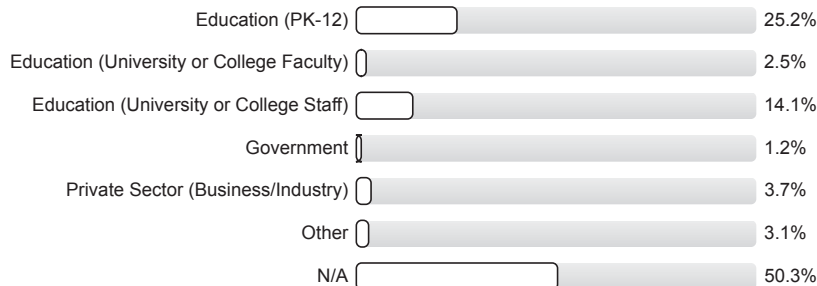

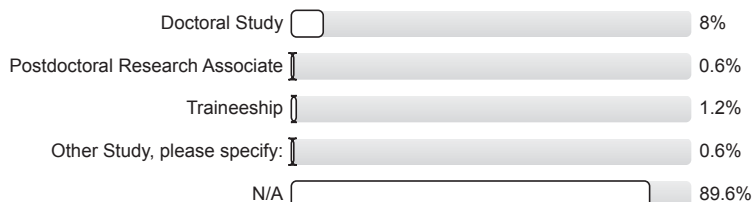

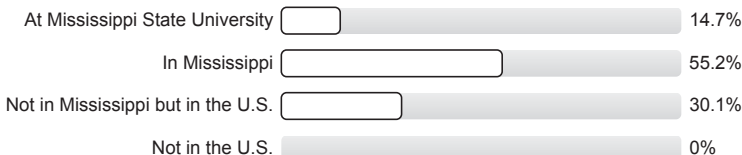

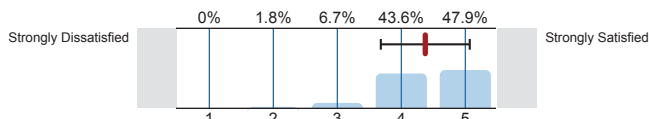

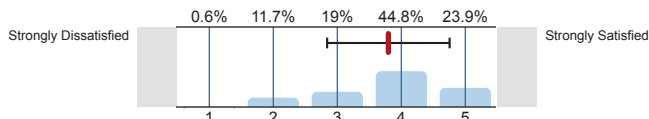

3.1) Graduate courses exhibited advanced academic content



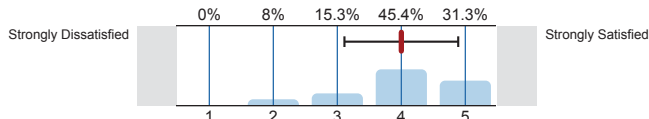

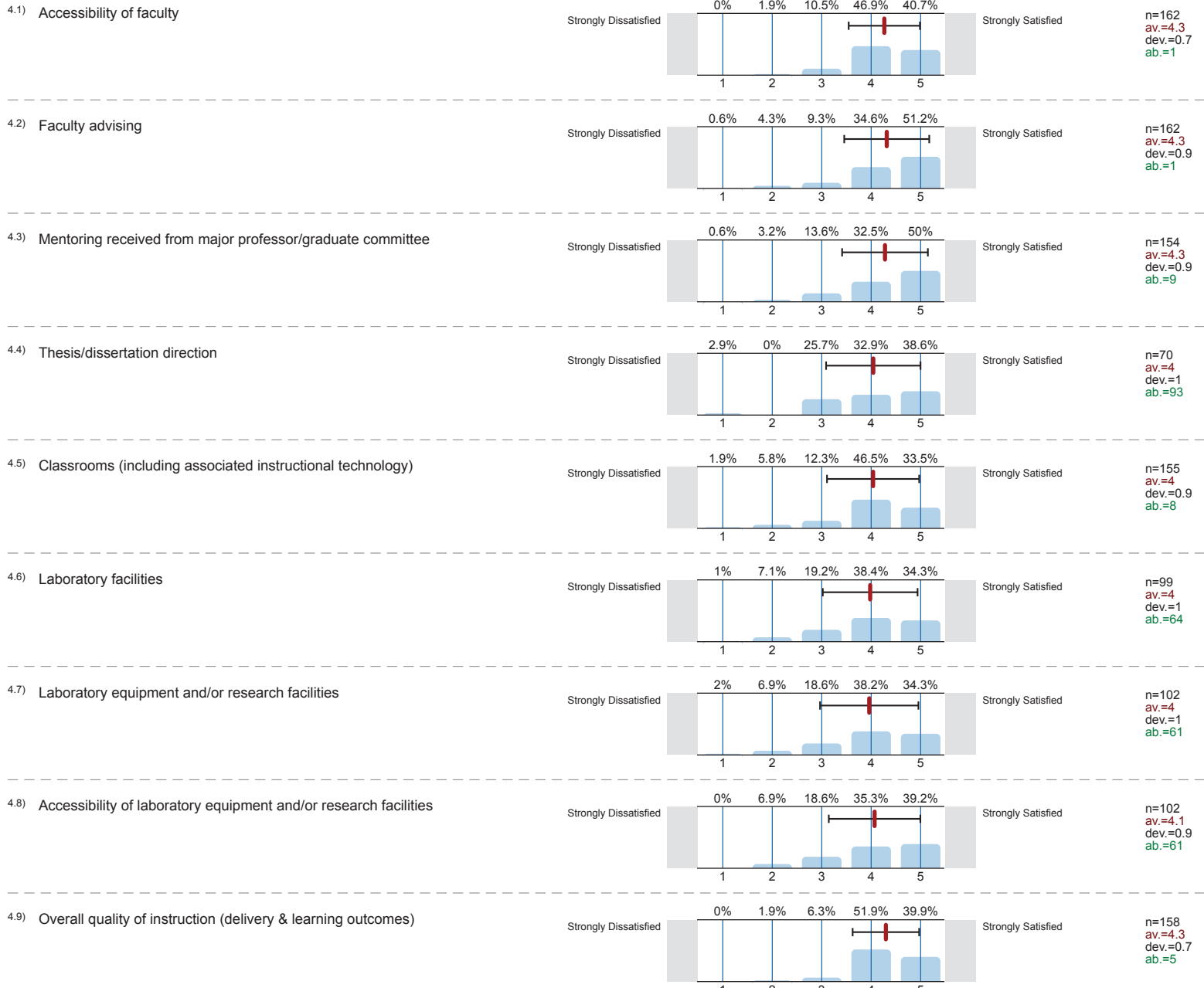
3.3) Variety of courses that were taught



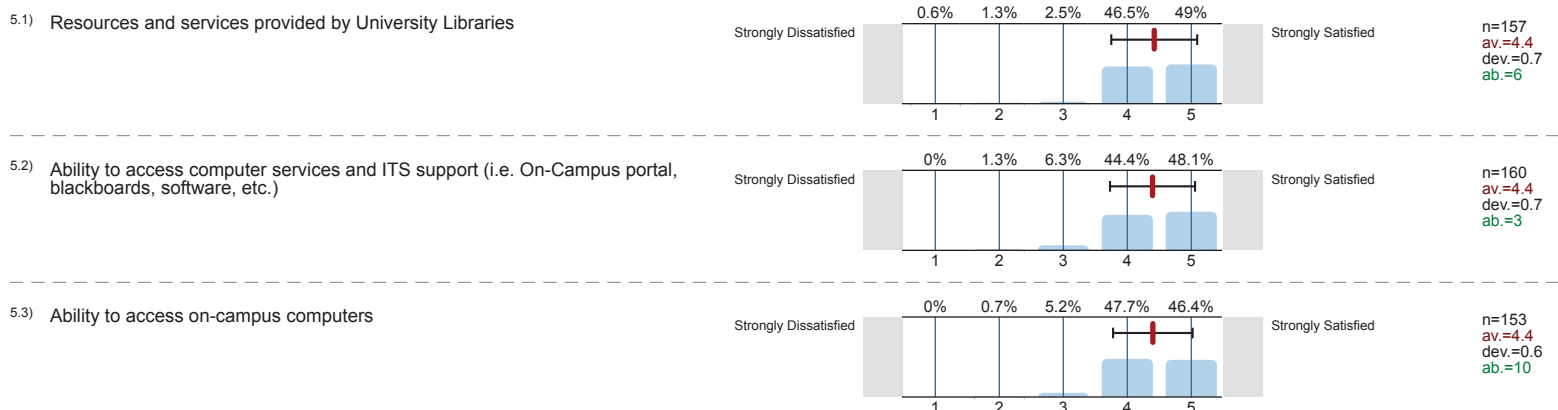

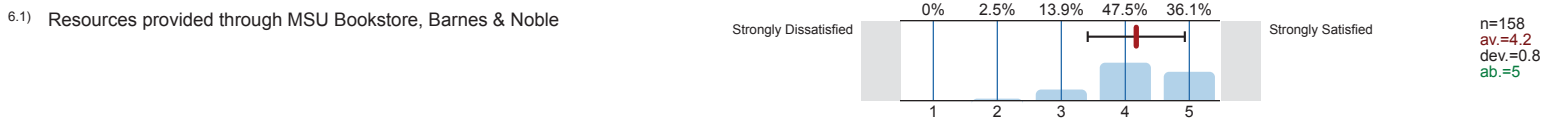
